Parents Rights and Resources



School oversight is managed by a considerable group of federal and state laws, regulations and ordinances. California nonpublic, non-sectarian schools that are certified to contract with public school districts to educate students with special needs are regulated by many more laws, statutes and requirements. The Haynes Education Center is certified by the California Department of Education as a nonpublic, non-sectarian school and fully complies with an expansive scope of laws, regulations and ordinances.

The Individuals with Disabilities Education Act (IDEA) is a law ensuring services to children with disabilities throughout the nation.

IDEA requires school districts to provide a "free appropriate public education" to eligible children with disabilities. A free appropriate public education means that special education and related services are to be provided as described in an individualized education program (IEP) and under public supervision to your child at no cost to you. Working in partnership with multiple Southern California area school districts, the Haynes Education Center is a free appropriate public education option for children with disabilities.

As a parent, you have a right to participate in any decision-making meeting regarding your child's special education program. You have the right to participate in IEP team meetings about the identification (eligibility), assessment, or educational placement of your child and other matters relating to your child's education.

The Haynes Education Center's experienced and knowledgeable staff is always available to discuss student and parent rights and procedural safeguards.
