The Haynes Family of Programs School strives to provide a safe and attractive location that facilitates and promotes learning. The school contains 5 classrooms, a computer lab, and a recreation room. The custodial staff provides daily maintenance of the facility at a time when it would not be disruptive to the instructional process. The facility meets the educational needs of the students. Emergency procedures are posted and reviewed with the faculty and students each year. Fire drills are performed according to education code. Visitation rights are granted with permission and it is mandatory to check in with the school office before entering school grounds. Gates remain closed during the school day and area opened only for emergency vehicles and at arrival and dismissal times for transportation vehicles. For the 2021-2022 the school will relocate to the David and Margaret Facility in the city of La Verne. In addition of the above the school will have a campus that provides a park like atmosphere with trees and lawns giving a much more relaxed and tranquil feel. The new area will also provide a workout gym, playground area and pool.

B. Pupil Outcomes

Where the most viable option, LEAs were required to administer the statewide summative assessments for ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:
 - Aligned with CA CCSS for ELA and mathematics;
 - Available to students in grades 3 through 8, and grade 11; and
 - Uniformly administered across a grade, grade span, school, or district to all eligible students.
 - **Options:** Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. - Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.
- **College and Career Ready:** The percentage of students who have successfully completed courses that satisfy the requirements for entrance to the University of California and the California State University, or career technical education sequences or programs of study.

All students participate in field trips to various locations and presentations by various guest speakers promoting various careers of interest. All trips and speakers must be submitted for administrative approval and requests must be accompanied by a lesson plan connecting the outing/speaker to work being done or presented in the classroom. All students prior to their 16th birthday are provided with an Individual Transition Plan that addresses post-secondary educational goals, employment goals, and living arrangement goals. This plan is included as part of the students IEP. Students starting at age 16 are provided with an opportunity to work with the Department of Rehabilitation with an independent living program that includes some supported employment. Seniors are accompanied to local colleges of their choice to meet with counselors, arrange dates for assessments, and register their Psycho-Educational Reports with the office of students with disabilities. Students participate in an on-campus work program. They must complete job applications and participate in an interview. Staff critique the interview and give constructive suggestions to help the student learn about the interview process. Students re-apply and interview every quarter if they wish to continue with the current job assignment.

Addendum
